Smallwood seconded the motion. Robertson asked if all these had previous license. No further discussion. All in favor.

Smallwood made a motion to appoint Blair Northen as the Mayor Pro Tem for the 2023 year. Purvis seconded. No discussion, All in favor

Smallwood made a motion to appoint Crystal Smallwood as City Clerk/Treasurer for the 2023 year. Purvis seconded. No discussion. All in favor

Northen made a motion to appoint Scott Cole as the City Attorney for the 2023 year. Purvis seconded. No discussion. All in favor

Northen made a motion to appoint Mayor GW Davis as the Director of Public Safety. Smallwood seconded. No discussion. All in favor.

Mayor Davis stated there was 1 vacancy on the planning commission and he would take recommendations if anyone had someone in mind. No action was taken.

No citizen comments on non-agenda items.
