The honorable-mayor Jefferson Riley called the Special Called Meeting to order promptly at 6:30pm and asked if anyone would like to revise or approve the agenda. No council made any revisions, however, the honorable-mayor Jefferson Riley asked that an item 'b' be added to New Business unable to recall exactly what it was for at that time. Councilman Perry Lunsford made a Motion to approve the agenda as revised and Councilman Bryan Hale gave the Second. All council present voted 'aye' and the Motion to approve the revised agenda passed.

The honorable-mayor Jefferson Riley said the invocation and led everyone in the pledge of allegiance. He welcomed everyone and reminded them that there are 2 meetings left for this year, the work session and council meeting for December.

Moving along, the honorable-mayor-pro-tem Chris Fulmer made the Motion to approve Ordinance #O-112816 to complete the annexation of the 13.868 acres on Hwy 213 described in Appendix A attached. Councilman Perry Lunsford gave the Second. All council present voted 'aye' and the Motion Passed.

Item 'b', the final item the honorable-mayor Jefferson Riley raised was about the excess equipment the City has that is inoperable. He stated that there are 2 police cars, the old garbage truck and the dump truck, that is on its last leg. He stated that the City bought the dump truck from the City of Oxford for \$1,200 a few years ago. Councilman Bryan Hale said it was a "rolling violation". The honorable-mayor Jefferson Riley suggested that the City needs a truck with a dump body. The honorable-mayor-pro-tem Chris Fulmer asked if the City needed a 1-ton dump truck instead of a pick-up truck and should it be new or used. The honorable-mayor Jefferson Riley and Councilman Perry Lunsford answered that it should be new. Councilman Perry Lunsford also suggested that a depreciation allowance be set aside for future purchases.

AN ORDINANCE TO ANNEX PROPERTY INTO THE CITY OF MANSFIELD, GEORGIA, PURSUANT TO CHAPTER 36 OF TITLE 36 OF THE OFFICIAL CODE OF GEORGIA ANNOTATED; TO PROVIDE AN EFFECTIVE DATE; AND FOR OTHER PURPOSES

WHEREAS, the Blackwell and Bruce, Inc. (The "Owner") petitioned the City Council of the City of Mansfield, Georgia for annexation of real property located on Highway 213 into the limits of the for use as the location of a pump station;

WHEREAS, the real property Owner seeks the City of Mansfield to annex into it boundaries is described in Exhibit A attached hereto (the "Property");

WHEREAS the Property is contiguous to the boundary of the City of Mansfield;

WHEREAS, the City notified the Newton County Board of Commissioners of the Owner's petition annex the Property into the City, and, after consideration, the Board of Commissioners of Newton did not object to the proposed annexation;

WHEREAS, after thoughtful consideration, the City Council of the City of Mansfield, Georgia is in favor of such petition

NOW THEREFORE, BE IT ORDAINED BY THE GOVERNING AUTHORITY OF THE CITY OF MANSFIELD:

- Section 1. The area owned by Owner as described in Appendix A which is attached to and incorporated as part of this ordinance, is hereby annexed into the City of Mansfield and is made a part of said city.
- Section 2. This ordinance shall become effective on the 28 day of November, 2016.
- Section 3. The Mayor, City Clerk, and City Attorney of the City of Mansfield are authorized and instructed to take any and all action, and to execute any documents necessary or in good faith believed necessary to complete the annexation of the Property and/or to timely notify the appropriate state and local governmental agencies of such annexation.

an 4. All ordinances and parts of ordinances in conflict with this ordinance are repealed.
