The meeting was called to order at 7:00 pm.

Councilman Ashlan Troutman made a motion to approve the agenda. Councilman Bret Dunn gave the second. All council voted 'aye'. The motion passed 5/0.

The honorable-mayor Pro Tempore Bret Dunn gave the invocation and lead everyone in the pledge of allegiance.

The honorable-mayor Jefferson R Riley welcomed everyone to the meeting and made a few short comments. He also announced an invitation to the 141-year church anniversary service of Mt. Zion AME with Host Pastor Noah Nyamaropa and guest speaking Pastor Justin Adams, who is a Mansfield resident and read a letter he wrote to the City's residents that is attached to the agenda.

Mr David L NaDell Sr, 3145 Hwy 11, thanked the mayor and council for moving forward with the downtown project and shared that the Mansfield Super Senior group currently has over 60 members. Mrs Renay NaDell, 3145 Hwy 11, also thanked the mayor and council for their decision to move forward with the downtown project and added that she will enjoy riding her bike on the trail. She also stated that she has seen several city downtowns across the state and nation that have been redone. Mr Blair Northen, 3800 Hwy 213, comments that a good looking downtown will be nice but should not be a priority. Mr Northen also asked the City to address a roadway issue near the elementary school. As a result of the request from Mr Blair Northen and the ongoing comments regarding the City's roads and sidewalks, the honorable-Mayor Jefferson R Riley asked Councilman Bryan Hale to do a written assessment of the concerns to present too Mayor and Council at the next Council Meeting. The honorable-Mayor Jefferson R Riley asked Councilman Hale to call him if he would like his assistance with this request

Newton County Sheriff Deputy Cox shared that there were not community concerns to pass on but asked if there were any concerns she could report to the Sheriff, other than speeding. She also included that she has noticed the speed humps that have been installed around the City and wanted to make the
