The meeting was called to order at 7:01PM.

The honorable Mayor GW Davis Jr asked for prayer requests from everyone present and then asked us all to join him in a moment of silence remembering the requests just made or observing in the way they felt appropriate. He then led everyone in the pledge of allegiance.

Councilman Blair Northen asked to revise item VI. New Business b. on the Agenda to read, R Clark Matter and Other Court Documents. Councilman Austin Mitchell made the Motion to adopt the agenda as revised and Councilman Bryan Hale gave the Second. All Council voted 'aye'. The Motion passed 5/0.

There were no citizen's comments on agenda items.

Councilman Austin Mitchell made the Motion to approve the March 8 2021 Council Meeting Minutes and Councilman Marty Smallwood gave the Second. All Council voted 'aye'. The Motion passed 5/0.

Since the City is not actively seeking warrants, etc. they are clearing or getting rid of the books. There has been a letter drafted by the city attorney to provide to future individuals, if needed. Mr Chris Fulmer, 150 Pine Street, commented on his support of paving the City's portion of Cricket Frog Trail when funds are available to do so.

The honorable Mayor GW Davis Jr gave a brief update of the state of the City's businesses, sharing that the two empty buildings on First Avenue have been leased, there was an offer made to Hays Tractor for their property, but they did not think it was a fair offer. In the meantime, they will continue to clear and

Mayor Davis then thanked everyone for being present and putting Mansfield first. He thanked the council for being diligent and hardworking representatives of the residents of Mansfield.
