The honorable Mayor GW Davis Jr called the meeting to order at 7PM and reminded everyone of the sign-up paper, in the back, to make a comment on non-agenda items. He then asked for any prayer requests. Mr Jefferson Riley asked for one of his employees, battling cancer, to be remembered. After a moment of silence, Mayor Davis led everyone in the pledge and immediately introduced Newton County Commissioner Chairman Marcello Baines for the Bicentennial Flag Presentation. Chairman Baines explained that this year Newton County is 200 years old and in celebration of its bicentennial birthday and to show that the county cares about the communities and what the mayor and council does, they are presenting each municipality with a flag to commemorate this milestone in Newton County's history. In return, the honorable Mayor GW Davis Jr then read the Proclamation and both gentlemen exchanged items.

Councilman Austin Mitchell made the motion the adopt the agenda as presented and Councilman Bryan Hale gave the second. All Council voted 'aye'. The motion passed 5/0.

Councilman Austin Mitchell gave the second and all Council voted 'aye'. The motion passed 5/0.

Mr Steve Black, 141 Pine St, addressed the mayor and council to request an extension of his variance request from September 9, 2019 that allowed him to park his motor home on his property while he built

There were several questions from Councilman Marty Smallwood and he also explained to Mr Black that the variance extension will be on a month to month basis for now. Other council asked a few questions as well. Mr Black said all he can do is beg to allow them to stay on the property and it will be done. Councilman Blair Northen made the motion to approve a 30-day variance for the motorhome to stay on the premises to ensure framing begins on the site. Councilman Austin Mitchell gave the second. All Council voted 'aye'. The motion passed 5/0.
