Mayor Northen gave an update on The Sewer Treatment Plant contract, final signatures Monday February 17th at 2 pm at City Hall.

Mayor Northen gave an update on House Bill 581 (HB581) no action taken. Limits increase on Property Tax.

Mayor Northen presented the social media Policy- A document has been prepared that all city employees will be signing and agreeing to NOT post or comment on any City related business.

Mayor Northen presented the Emergecy Procedures and Information- We are looking into a mass alert system Call/Email/Text system that will send a text, call or email to anyone who signs up, so as soon as anything occurs, we can get the correct information out to the residents faster and accurately. Also, Newton County has started a camera registry program, cameras will be going up on telephone poles within the next week on the City Limits.

Mayor Northen presented Downtown Parking and Congestion with more business and more residents, we are looking into more parking, possibly the lot diagonal from Roosters. 2 acre lot. We are also looking into a green space, parking area, behind the depot, next to the trail with public restrooms.

Mayor Northen presented the NO parking on Main Street, goes along with Downtown Parking and congestion, ordinance passed last year with NO parking on Hwy 11 from County Road 213 down to Kellogg. Once DOT is complete with signs and markings, the sheriff's office will implement no parking.

Mayor Northen presented the Spectrum investment; they are working on the second half of Mansfield they are replacing about 4 poles and should be complete with almost all residents in Mansfield being able to have an internet option.
